"I would like to see more daylight in this area, by removing some of the trees in this area." - Difficult to achieve because of the typography, because of rail embankment and old chalk quarry. • A catchment based approach is needed as this is not an isolated site but an on-line pond • Since road drains and surface run-off (that is not captured by drains) seems to contribute half of the silt this needs to be investigated with Hampshire Highways/Flood Defence first to remedy this. Road drains also contain pollutants that need filtering out before entering rivers directly perhaps by balancing ponds/marshes. • Water quality of pond and the river downstream need investigating with measurements of NPK, heavy metals, turbidity and cyanobacteria (certain times of year). Some technical services will be needed. • Taking the pond offline would help and maybe use the "Lasham Drain" culverted spring source that flows from brewery and under railway by the pond to enter at Waterside Court. "Lasham Drain" is culverted through the former brewery site and might currently be at risk/built over if they are not aware of it – needs investigating by Environment Agency • Explore and visit other cases of taking ponds offline, e.g. one in Wantage area, trail leaflet online. • EU Water Framework Directives (good law) need following in respect of rare chalk streams of international importance. Important to improve headwaters and this is an achievable goal • Achieving balance between amenity, blodiversity and environment. 	4.* On a few occasions I didn't stop as it wasn't clean enough to be attractive - but I often pass by. If Kings Pond were changed back to a river, the most satisfying channel pattern would be a meandering stream with perhaps an oxbow lake. It would help people enjoy and connect with nature. Channel width and meander radius need to relate to the volume of discharge. Plus one would have to be prepared for meanders to slowly travel downstream due to erosion on the outside of the meander in a slightly downstream direction and deposition on the inside on the meander (river cliffs and slip-off slopes or beaches) However changing Kings Pond to a river might no be appropriate because of the flow and fluctuating discharge of the river. Do you have discharge statistics for the flow where the feeder stream enters the pond and where it leaves, over a year? The feeder stream head water seems to be winterbourne with good flows in the winter and drying up in the summers due to the fall in water table in chalk. Therefore the green space would just have a dry river bed much of the year. Still good for some wildlife but not the very visible sort. So leaving the pond as it is might be the best option. Is it a mill pond in origin? (Paper-mill lane) measures that could be taken to improve water quality and appreciation could be:- Reduce access to the waters edge to jetty areas between reed bed edging Some cover by water lilies seems to reduce the number of geese using a water area (only an observation) - to more sustainable numbersOxygenating native plants plants -Trees and shrubs back a distance from the water so that there is less leaf fall and decomposition in the water Notices to explain why ducks should not be given bread - Duck food dispensers e.g. Alresford & Stockbridge (2 - one at either end of the site) for 20p a handful - A part-time warden to check problems, vandalism, and make good, damage and hazards. 23	We have just had exactly the same situation with Pill Pond in West Burton, West Sussex, where the Parish Council has been persuaded to remove the pond to avoid the cost of dredging. In both cases, the cost of infrequent dredging would be much less than the engineered solutions being proposed. Moreover, the idea of an offline pond is completely impractical. It would require considerable engineering and maintenance in order to manage water levels. Moreover, dredging will still be needed from time to time, because silt laden water will still enter the offline pond, albeit at a slower rate. The idea is to 'return' the pond to a free-flowing chalk stream, but in the process the ecological benefits and aesthetic benefits of the pond will be destroyed. A more natural flow would be preferable and could become self cleansing provided the rest of pond were retained and managed appropriately. A similar scheme is being proposed for a pond in Andover and there are other examples where this has worked well. We should also recognise that managing these open spaces to create improved open spaces that are sympathetic to wildlife and enable that connection cannot come at zero cost. 40	While registering my support for the primary recommendation in 2.1.3, I would certainly not wish the entire area of open water to disappear. Standing, as well as flowing water, can provide habitat for many forms of wildlife. Currently, however, the ecological value of the pond is very poor, especially with regard to aquatic invertebrates. I therefore accept the ecologically-based arguments which have been made in favour of taking the pond off-line and implementing measures to reduce the input of nutrients and pollutants. I hope very much that habitats for wildfowl will continue to exist on-site but there is a clear need to overcome the impacts of an over-sized, over-fed bird population on the ecology of the site and, potentially, on human health. With regard to grass cutting, I have selected the option of "less frequent" only because I am concerned that mowing the entire area in spring or summer could prevent various kinds of invertebrate (e.g. grasshoppers) from completing their life-cycles. pond as it is such a tranquil place to walk around in the middle of town and of course it provides a superb circuit for you to walk around as many times as you wish. Whenever we have friends come to visit we always take them to see the pond. Kings Pond is a great open space and an asset for Alton, something we need to cherish and preserve for future generations. I agree that the population of Canadian Geese has grown to me what appears out of control. Measures need to be taken to reduce their numbers. I do like to see them though, especially when they fly in formation over my house on summer evenings. So wouldn't want to see them totally eradicated. Sadly during Covid the rat population took hold at the pond and it seems they have been a problem since. I believe that this was due to several factors; when people fed the ducks they let food drop onto the ground, overflowing bins and the redevelopment of the brewery site and opening up of the culvert that ran through the site. This appears to have improved and I thank the work of the council to tackle this. I have attended both meetings at the pond and in the Assembly Rooms and the main argument for taking some action seems to be the poor quality of the River Wey, one of a limited number of chalk streams. I believe that Alton Town Council need to consider the following points; Your proposed feasibility study seems too narrow, surely you need to look at what is happening upstream too. There has been a large amount of redevelopment in Alton over recent times. Rainwater that would previously peculate through the soil and refill underground aquifers now runs into drains. I understand that Alton receives its water from Lasham. The pumping station at Windmill I understand supplies water to Bordon, another town with a huge amount of new homes. Surely all of this also effects the quality of the River Wey if its source isn't as plentiful. Silt appears to be a major problem and this has been resolved previously by dredging. It has been mentioned that the silt could be toxic but I do not believe this has been tested. It could be fertile and used on surrounding farmland. It could also be used to build back up the island in the centre of the pond or even on the banks of the pond to slightly reduce the ponds size. This would hopefully speed up the flow of water leading into the pond and out of the sluice. There is also an area along Ashdell Road just before the railway bridge that dips down, could you not put some of the silt there? As previously stated Kings Pond is a recreational area used by many people in the town. It is an asset and beautiful feature. The Council just need to maintain this and not let it be taken away. They appear to be wanting to take the cheapest option for them but not the best for future generations living in Alton. Please Alton Town Council save our pond! in the context of the whole river system from source to Haw Bridge, Holybourne Within the On-line Consultation Alton Town Council (ATC) have narrowed their focus purely on the Kings Pond. The On-line Consultation and Proposed Management Plan should include the entire river length and adjacent water catchment areas located within the Town Council jurisdiction. Over recent years there has been significant urban development, especially near Will Hall Farm upstream of Kings Pond. The Draft Management Plan prepared for Alton Town Council in August 2022 presents suitable options, including the Priority Action (2.1.3) pursuing a more sustainable alternative to expensive pond dredging. It is a suitable response to well reasoned Environment Agency advice (Appendix A). A healthier chalk stream, off-line from a wetland scrape, or smaller pond (concepts 1 and 2) are a different amenity to the larger open water of the current Kings Pond. Such alternative concepts supporting taking the River Wey off-line should be recognised as valuable by those with an interest in King's Pond. The amenity of King's Pond would not be lost, it would simply be different. The Priority Action (2.1.3) should be supported by Alton Town Council as it continues to seek and to share expert input to the future management of King's Pond. I have voted against the feasibility study, because I distrust the Council's motives behind holding one. The main reasons that have been presented for holding a feasibility study are environmental, however I strongly suspect the primary reason is economic, (particularly when the Council is strapped for cash and for the environment agency off-lining the pond would be the cheapest option). I went along to one of the consultation meetings, where I expected to be able to have a proper conversation about my concerns relating to the potential off-lining of the pond, and the response I had was 'Have you read the plans and our Q&A', to which I responded that I had, but that I still had concerns that had not been addressed. These concerns are as follows: Firstly, I am concerned by the emphasis that the Consultation Brief puts on Dr David Murdoch's letter. I understand that he is a Vice County Dragonfly Recorder and was disappointed not to record any dragonflies at the pond the day he came around. However I live on the road directly behind King's Pond and have witnessed huge dragonflies in my garden, which, because there are no ponds along my street, I would suggest have come from King's Pond. Furthermore, I find it incredible that this recorder can say that King's Pond is effectively a desert for biodiversity. Everyone who studies GCSE Biology, and some people such as myself who go on to study Ecology at University, knows that energy is passed up the food chain, and only if there is an adequate food supply at the lower levels will there be enough to sustain the organisms at the higher trophic levels. King's Pond is home to species on the these higher trophic levels, such as Daubenton's bat. This species would not be able to survive around the area if there were too few invertebrates breeding at the pond, so there must be a high enough level of insects to support them. Whilst the Daubenton's bat is a secondary consumer feeding off the invertebrates, the pond is also host to tertiary consumers such as herons and kingfishers. These species feed off fish, which are secondary consumers. In turn, the fish are feeding off the invertebrates, which are the primary consumers. Therefore, the fact that we can see the pond supports so many different species at the tertiary consumer level and so many within a species at this level (a heronry of three nests for example) it is clear that King's Pond has a high carrying capacity for a number of species. The list includes moorhens, coots, little grebes, visiting cormorants and little egrets, plus kingfishers not to mention the geese and a variety of ducks and garden birds. The off-lining of the pond would be devastating to a number of these species. By off-lining the pond the fish would be deprived of fresh spring water; the pond is likely to become stagnant and the fish in the main stream would not be able to move into the pond to breed. This would lead to the effective removal of fish from the pond. Having established that fish are a core source of food for kingfishers and herons, why was it not mentioned in the briefing paper that off-lining the pond would result in the loss of these species? Similarly, if the pond is shrunk it will not have the same carrying capacity for invertebrates, and this could see the disappearance of the Daubenton's bat. Furthermore, the mute swans would no longer be able to live at the pond as they would not have a long enough runway on which to take off. I acknowledge that the pond's current nutrient levels are not at the optimum state of health. However, there should surely be a concerted effort to deal with this before considering off-lining. I have watched as there has

been increased building work around the pond and noticed the pipe above the River Wey tunnel entering the pond chucking out murky water, which I can only suspect comes from the nearby building site. The brief acknowledges that the pond suffers from run-off from Ashdell Road but fails to mention that there is now development along the entire course of the river, from the source to the pond and beyond. Another concern relating to the option for off-lining and shrinking the pond, is that it will become a boggy mess. People will trample all over any potential wildflowers that could grow, and there will be even more dog poo as dogs will have a greater run of the place, and when the dog poo is next to the pond or stream, the nutrient loading will be even worse. Dog poo is less likely to be picked up by people when there is long grass as they think they can get away with it. So the plans for bog patches and boardwalks (which would discourage owners from going into the boggy part to pick up the poo) would contribute to the degradation of the area and as a result a degraded public amenity. There has been considerable research, including by the University of Exeter, on the importance of large bodies of water such as lakes and beaches to improving people's well-being. Short and frequent walks near bodies of water have been shown to improve people's mental health. Shrinking this amenity and making it into a little piddle will not provide the same benefits that can be reaped from it today. People from all walks of life visit King's Pond, whether it's children on the way to school, local workers on their lunch break, elderly people looking for peace and quiet or dog walkers. King's Pond is a natural haven in the centre of a town that is growing and growing. A recent study by the University of Exeter has now shown how positive childhood experiences of blue spaces are linked to better adult well-being. Shouldn't having a positive legacy for the community be a goal for the town council to aim for? The pond provides a space to breathe and think. To shrink it would be a tragedy and deeply degrading to the assets of the town. It would mean it would lose its only large body of water - and in turn the unique ecologies that can only thrive on large bodies of water. During the consultation I asked whether there would be public participation relating to the direction of the management of King's Pond following any feasibility study. The response I received was uncertain. I want certainty that there will be public participation during the whole process of the management of the pond. In particular, I would refer the town council to Emily Barritt's book 'The Foundations of the Aarhus Convention: Environmental Democracy, Rights and Stewardship'. This book highlights the importance of deliberative democracy, where the public is involved throughout the management process, and not only are they 'listened to' but their ideas and feelings actually guide the decision making. Hence, there is communicative interaction, rather than being listened to in one ear and ignored in the other. The Aarhus Convention, is an international convention to which the UK is a signatory and grants the public access to information, participation in decisionmaking and access to justice in respect of environmental matters. I hope that Alton Town Council will stick to the terms of the Aarhus Convention, otherwise it would be worthwhile for residents to look into how they can mobilise their procedural rights under the convention to ensure full participation is enabled. Finally, it is my reference to the Aarhus Convention that brings me back to my first point, relating to my distrust of the real motivations behind the feasibility study. The lack of confirmation as to whether there would be public participation following a feasibility study, has led me (unsurprisingly) to fear that having the feasibility study granted would provide a green light to the town council to go ahead with off-lining the pond. Once the feasibility study is complete the council could try to say that participation was enabled during the process, so they can decide on the results themselves without a further consultation with the public. I would like to be assured that the council would adhere to the precautionary principle, whereby policy makers take time to stop and review the impact of a proposed project and see what the potential effects of it could be and the extent to which there may be unknown potential harms of carrying out an activity. It requires asking if an activity could have unforeseen damaging effects, and if so, can they be reversed or are they by that point irreversible? Do we know the full cumulative impacts that removing the pond will have on all its wildlife? No studies have so far been conducted to determine this. Ploughing ahead with a feasibility study without first carrying out a cumulative environmental impact assessment is the same as breaking down the precautionary principle and not giving due consideration to the potential impacts. Once King's Pond is gone, it will be gone forever. The brief downplays the idea of dredging as an option because it disrupts wildlife. However, whilst dredging does have a disruptive impact, this is only short term and we know from past experience that the wildlife returns after the pond has been dredged. On a final note, I understand that the dredging option is more expensive than off-lining would be, but is the cost of dredging once every quarter of a century really too high to bear given the importance of King's Pond to local people? I would rather see a rise in the Council tax, than see the destruction of the pond.
